AND

National Bank for Agriculture and Rural Development a body corporate established under an Act of Parliament, viz., National Bank for Agriculture and Rural Development Act, 1981 having its Head Office at Plot No. C-24, G-Block, Bandra Kurla Complex, Bandra (E), Mumbai - 400 051 and one of its Regional Offices at Odisha, Bhubaneswar hereinafter referred to as "NABARD", (which expression shall, unless it be repugnant to the subject, context or meaning thereof, deemed to mean and include its successors and permitted assigns from time to time, as the context may require or admit) represented by Shri/Smt/Ms N. L. SAHOO, working as Deputy/Assistant General Manager, NABARD **OF THE SECOND PART.**

NABARD and AGENCY shall hereinafter, where the context permits, be referred to individually as "Party" and collectively as "Parties".
